# Promoting Access. Improving Health.

MeHAF: Access to Health Care and Improved Health. That's what we get if we boil down the MeHAF mission to a tweet. In 2000, when MeHAF was established, there was a strong belief that this abbreviated version was correct. That indeed, health care was the major contributor to health.

When we go beyond the Twitter version of the MeHAF mission, we see the other important elements: "quality," "uninsured and underserved," "everyone in Maine." Throughout the past decade-and-a-half, we have deepened our understanding that these other elements are essential if we hope to have success.

Increasingly, MeHAF's grantmaking and other programmatic activities foster work that addresses multiple elements of the mission all at the same time. The stories in this annual report feature innovative and effective examples of grantees whose work embraces this total-mission focus. Many changes occurred at MeHAF in 2016, but with no loss in our dedication to mission. We celebrated the accomplishments and fierce dedication of our founding President and CEO, Dr. Wendy J. Wolf, as she stepped down from her position. We also bid farewell to our talented long-time Senior Program Officer, Becky Hayes Boober. The foundation moves forward into 2017 with a new President and CEO and two new staff members, Senior Program Officer Ruta Kadonoff and Program Officer Kathryn Rouillard.

Our commitment – that of the Board of Trustees, Community Advisory Committee, and staff – remains steadfast. Our organizational changes bring new passion to our work. # Learning from Those Who Are Uninsured and Underserved

A Mano en Mano staff member sits with a local Milbridge resident while conducting the 2016 Community Survey. In the Washington County town of Milbridge, as in many other places across Maine, seasonal migrant workers play a vital role in the farming and aquaculture industries that bolster the economy. In 2005, Mano en Mano was incorporated to support these temporary workers, along with the growing community of former migrants who have chosen to make Downeast Maine their permanent home. Since then, Mano en Mano has worked collaboratively with partners to put community voice at the center of their programs and services.

With the help of a 2016 MeHAF discretionary grant, Mano en Mano continued this tradition by working with Colby College and other partners to design and implement a community survey to guide their future work. Through intensive door-to-door outreach by bilingual staff, the survey reached the households of more than 200 members of the year-round immigrant farmworker community.

The survey results have provided an unprecedented level of insight into the health status, economic impact, and community strengths and needs of this segment of the local population. This community input is guiding Mano en Mano's new strategic plan and improving the organization's ability to understand barriers and connect clients to essential health services.

# Responding to a Health Crisis that Impacts Everyone in Maine

dolay's opiate crisis has touched communities across our state. Mainers have seen family members, friends, neighbors, and colleagues affected in one way or another. Just as there is no "typical" person who struggles with opiate addiction, there is no "one-size fits all" response for every community.

With MeHAF support, Maine Medical Education

Trust (MMET) facilitated 22 community forums across the state in 2016 to collect feedback about available and needed resources to support a comprehensive and sustainable response to the opiate crisis. In York County alone, MMET held forums in Alfred, Biddeford, York, and Waterboro. The forums, which in total engaged 1,500 people and many local social service agencies, have ensured that community members who have been impacted by the crisis have a meaningful voice in shaping potential solutions.

The candid input of participants that was gathered through the MMET-facilitated

community forums informed the recommendations of the Maine Opiate Collaborative (MOC), a group that was charged with developing a cross-sector, multi-dimensional approach to the opiate crisis. In addition, their collective efforts were instrumental in the design of MeHAF's new Addiction Care program.

# Improving Health with Community Supports

In Dover-Foxcroft and across Piscataquis County, MeHAF grantees demonstrate the power of place-based, community-driven initiatives to create meaningful change and support healthy, vital lives. Piscataquis Healthy Food for All, A Healthy Community Project and the Piscataquis Thriving in Place Collaborative Project are bearing fruit here through the efforts of the grantee organizations, the Piscataquis Regional YMCA and the Charlotte White Center, along with their many partners.

By listening, comprehending and responding to community-identified priorities, these projects are weaving together a network of services and supports to effectively meet critical needs, including connecting people in geographically remote areas with sources of healthy food, and building collaborative solutions that enable elders and persons with disabilities or chronic conditions to continue living successfully in their homes and to engage as integral members of their community. MeHAF is committed to learning from and working with communities across the state. When funding more than one grant in a particular community, we encourage cross-grantee collaboration to increase impact and accelerate results. Both of these grants required out-of-the-box approaches – grantee communities were called upon to identify innovative and creative ways to engage people who do not traditionally trust or seek services. Grantees reached out to one another and to new partners, learning where system gaps and duplication occur and gaining a more nuanced understanding of the needs of people in the communities they serve.

Like so many places in rural Maine, life here has not been easy in recent years due to the county's aging and widely dispersed population as well as high rates of poverty and food insecurity. A visible symbol of the community's resilience is evident in the renovation and repurposing of the mill complex, which has found new life here bringing jobs, housing and services. Another powerful testament to this community's spirit is the success of these two MeHAF-funded programs.

# enroll207.com - Promoting Access to Health Care Coverage

ith the passage of the Affordable Care Act, MeHAF seized the opportunity to help thousands of uninsured and underserved people gain quality, affordable health coverage on the Health Insurance Marketplace.

To encourage Marketplace enrollment, MeHAF began working with Dirigo Design & Development in 2013 to create enroll207.com, a website that connected Maine people with Marketplace enrollment help in their communities. We then engaged Burgess Advertising & Marketing to build a comprehensive marketing campaign using TV, radio,

print and social media to spread the word about enroll207.com and the availability of affordable health plans.

The results? For the last three years, Maine has had some of the best enrollment numbers in the country with nearly 60% of eligible people enrolling in health plans on the Marketplace. While enroll207.com is not entirely responsible for the state's enrollment success, we know it built a level of awareness that played an important role.

Marketing campaigns aren't usually associated with improving access to health care, but the enroll207.com campaign helped get thousands of Maine people covered so they could get the care they needed when they needed it.

# Advancing Quality Health Care through Peer Support



"Our role as peers brings unique value to individuals in treatment that can help them be successful." People in central Maine with mental illness benefit from a long-term collaboration among mental health agencies called Mid-Maine Behavioral Health<sup>[1]</sup> (MMBH). In 2014, MMBH received a MeHAF grant focused on supporting community mental health providers to participate as a "Behavioral Health Home," a new MaineCare effort. Behavioral Health Homes create close linkages between mental health and primary care to ensure bettercoordinated, more holistic care for individuals with mental illness.

A primary focus of MMBH's project was to build meaningful and

sustainable peer involvement to improve the delivery of services. Peers themselves helped to identify "peer points" of involvement that would maximize their impact to complement the work of mental health professionals. "Our role as peers brings unique value to individuals in treatment that can help them be successful," said Joyce Gilbert, a Peer Consultant who works with Crisis & Counseling and Kennebec Behavioral Health.

Peers have become part of the fabric of care provided by MMBH and its partners, and this new approach will continue into the future.
