## Maine Resilience Building Network

#### **Youth Thriving in Franklin County**

The Maine Resilience Building Network (MRBN) will increase Franklin County Healthy Community Coalition's (FCHCC) capacity to integrate a "youth mattering" lens to its coordinated, community-based public health approach to address youth mental health by executing MRBN's Maine Youth Thriving: A Guide for Community Action (MYT) community engagement programming and training.

**Community of Focus:** Youth who are likely to feel disconnected: especially BIPOC, LGBTQ+, youth with disabilities, and youth that have recently migrated to the US and Maine.

County of Focus: Franklin

#### **Mainely Teeth**

#### **Expansion of MaineCare Oral Health Provider Network**

Mainely Teeth will create partnerships with private practice oral health providers to expand the number of providers serving MaineCare patients by eliminating barriers to participation created by the administrative requirements of MaineCare intake and billing. Mainely Teeth will provide these functions on behalf of private practice partners to increase access to care for patients regardless of their geographic location.

**Communities of Focus:** Primarily pediatric patients insured by MaineCare, but includes all who may experience barriers to care based on geographic location, transportation, uninsurance, or underinsurance.

#### **Bringing Care to Sagadahoc County Youth & Young Adults**

Midcoast Youth Center will develop innovative solutions that eliminate barriers and improve health outcomes for teens and young adults by designing an on-site health clinic at the teen center to provide comprehensive, consistent, and ongoing care for medical, mental health, and substance misuse in a trusted location.

Community of Focus: Youth ages 10-24 who experience barriers to care.

County of Focus: Sagadahoc

## Greater Portland Addiction Collaborative Pilot: Contingency Management for Stimulant Use Disorder (GPAC CoMS Pilot)

Spurwink will implement and evaluate a contingency management pilot program, in collaboration with the Greater Portland Addiction Collaborative, based on the Treatment for Individuals who Use Stimulants (TRUST) model for adults with co-occurring serious mental illness and substance use disorder.

**Community of Focus:** Individuals with stimulant use disorder (StimUD), especially those experiencing homelessness, intravenous drug use (IVDU) acquired infection, and multiple hospitalizations.
